The e-Voting period shall commence on Saturday, September 20, 2014 from 9.00A.M. (IST) to 6.00 P.M. (IST) during this period Shareholders of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off date i.e. record date of July 18, 2014, may cast their vote electronically. The e-Voting module shall be disabled by CDSL for voting thereafter. Once a vote on a resolution is cast by the shareholder, the shareholder shall not be allowed to change it subsequently. The Company has appointed Dr. D.K. Jain, Company Secretary in practice as the Scrutinizer for the postal ballot process.


