Pursuant to SEBI circular No. **SEBI/HO/ISD/ISD-PoD-2/P/CIR/2023/124 dated 19<sup>th</sup> July, 2023**, and SEBI circular No. **SEBI/HO/ISD/ISD-PoD-2/P/CIR/2025/55 dated 21<sup>st</sup> April, 2025** company is required to give prior intimation to designated depository appointed by the company i.e. CDSL atleast 2 (Two) trading days prior to commencement of the trading window closure through online mechanism.
